### Village Community Empowerment Support Againstwest Bali National Park Hall, Jembrana Regency

#### **ABSTRACT**

West Bali National Park, Jembrana Regency is a nature conservation area that has native ecosystems, managed with a zoning system that is used for research, scientific, educational purposes, to support cultivation, tourism and recreation. West Bali National Park, Jembrana Regency is the only national park in Bali Province. Local wisdom is one of the things that must be considered in Environmental Protection and Management activities, especially in community activities to preserve the protected forest of the West Bali National Park. Partner Issues: 1) Lack of optimization of local wisdom towards the West Bali National Park in Supporting Village, especially Melaya Village, 2) There is no synchronization of the rights and obligations of the parties to the Conservation contract between the Village community and the Village Head, especially the Melaya Village. The research method used is empirical legal research, namely by primary data collection through observation, interviews, and distributing questionnaires. After the primary data has been collected, it is processed, using qualitative methods and analyzed using Descriptive analytical techniques to get conclusions with accurate data. The output targets of this service are: To form a draft conservation contract between the Village of Support (Desa Melaya) and the West Bali National Park Center, a reputable accredited Service Journal (Community journal of Law) and the Sutramas Journal, HKI, Print Media.

#### I. INTRODUCTION

A tourist village is a form of tourism where a small group of tourists live in or near the traditional life of remote villages and study the village life and the local environment (E, 1991). A tourist village integrates attractions, accommodation, and supporting facilities presented within a community life structure that combines with the prevailing culture and traditions (Nuryanti, 1993).

West Bali National Park, Jembrana Regency is the only national park in Bali Province. Furthermore, Bali is an island of the gods which has become an international tourist destination, so the West Bali National Park in Jembrana Regency has very high potential to be developed. West Bali National Park (TNBB) Jembrana Regency is geographically located at coordinates between 8 degrees 5 minutes – 8 degrees 13 minutes south latitude and 114 degrees 26 minutes – 114 degrees 35 minutes east longitude. This area is located in the administrative area of Gerokgak District, Buleleng Regency and Melaya District, Jembrana Regency, Bali Province. The exact location of the West Bali National Park is 60 km to the northwest from the capital city of Bali, Denpasar.

On 15 September 1995 the Minister of Forestry Decree No. 493/Kpts – II/95 to confirm the determination of the status of the West Bali National Park area with an area of 19,002.89 hectares. This area has also been designated as a World Heritage Site. The Government of Indonesia has established regulations on environmental protection and management in the form of Laws and Government Regulations nationally. At the regional level, these regulations are translated into regional regulations. As for specific problems, it is specifically regulated in a Ministerial Decree or Ministerial Regulation in charge of problems from that particular sector.

Laws and Government Regulations concerning the environment and development, including:

The implementation of Laws and Government Regulations in the field is supported by positive habits with the nuances of protecting and preserving the environment. In the West Bali National Park area, the management of TNBB involves a village bordering the West Bali National Park as a buffer village, totaling six (6) villages, namely: 1) Gilimanuk Village, 2) Melaya Village, 3) Ekasari Village, 4) Blimbingsari Village, 5) Pejarakan Village, and 6) Sumber Klampok Village.

Furthermore, each Buffer Village that provides support in the management and sustainability of the West Bali National Park in Jembrana Regency has a Community Group according to the conditions and situations of each Village, such as in the fields of Water, Plantation, Livestock, Fisheries, and others. On the other hand, the members of the Supporting Village community with the Community Group receive assistance and guidance and training related to the needs and needs of each community member in the Support Village community group. (Grzeskowiak et al., 2003) consider trust in local institutions as an important component of community satisfaction and argue that the construct contributes significantly to residents' attitude toward their community.

The trend emerges from the change in tourism motivation and patterns, from mass tourism to alternative tourism. The trend circles around the mature market—educated tourists who care much about environment conservation, community empowerment, and local culture (N & Topowijono, 2018).

The development of tourist villages is inseparable from the village authenticity, such as abundant natural potential or traditions or rituals carried out by the community. The local community is one of the stakeholders with an important position and role in supporting tourism development (Sunaryo, 2013). Therefore, the community's participation and function in developing tourist villages are essential to maintain tourism sustainability and make the village community prosperous. Local people give ideas for activities and management, and they can feel the benefits of such activities directly (Herdiana, 2019).

The practice of community empowerment has been done a lot, such as community service performed by Suandi et al., (2011) entitled "Community Empowerment through Development of Organic Agriculture Based Trikolimtan in Full River City of Jambi Province". The result of the community's dedication came to the conclusion that the community empowerment program that was done succeeded in increasing the community competence and increasing the farmer's income. The results of Kesi, (2011) under the title "Community Empowerment Model", concluded that the process of community empowerment in Desa Sumber Rahayu had a significant effect on community empowerment.

Participation has indeed long been the decoration of the lips of officials from the central to the village level that development and sustainability of development results will not succeed if it is not supported by "community participation (Adisasmita, 2013). The village plays an essential role in national development. Not only because most of the people of Indonesia live in villages, but villages make a significant contribution to creating national stability (Firman, 2015). Village development is part of a series of national development. National development is a series of sustainable development efforts covering all aspects of people's lives (Adisasmita, 2013).

The guidance and training provided by the West Bali National Park Office to the residents of the Supporting Village community through Community Groups can be in the form of: 1) Guidance on the fishery sector, such as how to maintain fish properly so that it can produce a lot of fish of superior quality, 2) Guidance on the waters sector, plantations, livestock sector, and others. The empowerment of the Buffer Village community towards the West Bali National Park Center is carried out by: 1) providing Legal Counseling related to policies that must be adhered to regarding the preservation of the West Bali National Park; 2) Optimizing the provision of guidance and training to the residents of the Buffer Village for the preservation of the West Bali National Park Forest Area; 3) Provision of nurseries related to the activities of the Buffer Village community group in the West Bali National Park Area. The output targets of this service are: To form a draft conservation contract between the Village of Support (Desa Melaya) and the West Bali National Park Center, a reputable accredited Service Journal (Community journal of Law) and the Sutramas Journal, HKI, Print Media.

#### II. METHOD

The location for the implementation of this community service is in the Village Support Center for the West Bali National Park, Jembrana Regency, Melaya Village which is part of the Melaya District, Jembrana Regency, Bali Province. The form of implementation is focused on empowering the Community of the Supporting Village, namely the Melaya Village in order to develop the potential of the village and strengthen the community's commitment to maintaining and preserving the conservation area of the West Bali National Park Center, Jembrana Regency.

Based on the three priority problems that are handled with partners, the steps taken to provide solutions to specific problems can be described as follows: The first step is to conduct initial observations to the location of the Village Support Service, namely Melaya Village, Melaya District, Jembrana Regency, Bali Province. Furthermore, the second step is to provide assistance to the Conservation contract that has been agreed between the Community Groups in Melaya Village and the West Bali National Park Office, Jembrana Regency. Following the steps taken in stages, it is possible for Melaya Village as a Supporting Village to become a prosperous and prosperous village, besides being able to help the West Bali National Park Office, Jembrana Regency, make it sustainable and become tourism that is crowded with researchers and members of the domestic and foreign community. In the implementation of this service by the service implementation team, each member has duties, including:

- a) Dr Luh Putu Sudini, S.H., M.Hum, in the field of International Law as head of service, have the following tasks: 1) Conduct an initial assessment to the Head of the Melaya Village and the Head of the West Bali National Park Office. 2) Looking for data at the service location (Balai Buffer Village of West Bali National Park, Jembrana Regency, namely Melaya Village) related to local wisdom, ecotourism, and the environment. 3) Assistance in drafting the draft contract between the supporting villages, namely the Melaya Village and the West Bali National Park Office, Jembrana Regency. Dan 4) Assistance in every service activity at the service location.
- b) Desak Gde Dwi Arini, S.H., M.Hum, in the field of Business Law as a service member has the following duties: 1) Assistance in drafting the draft conservation contract between the buffer villages, namely Melaya Village and the West Bali National Park Office, Jembrana Regency. 2) Companion in every service activity at the service location.
- c) Ni Made Widya Pratiwi, S.T., M.T in Civil Engineering has the following duties: 1) Mapping of data in the field of service locations. 2) Video making of service activities in 4 minutes. 3) Assistance in every service activity at the service location.
- d) Students of the Faculty of Law, with the task of helping the implementing team for community service every service activity.
- e) Students of the Faculty of Engineering, with the task of helping the implementing team for community service every service activity
- f) Mitra (Balai Taman Nasional Bali Barat), with the task of preparing a place for community service implementation, and providing the necessary data related to service activities.

#### III. RESULTS AND DISCUSSION

#### 3.1 Implementation of Community Service at Warmadewa University

Implementation of Community Service at Warmadewa University, through the Service Team led by Dr Luh Putu Sudini, S.H., M.Hum, with members Desak Gde Dwi Arini, S.H., M.H.Hum and Ni Made Widya Pratiwi, S.T., M.T with two students carrying out the service The community went to Klatakan Hamlet, Melaya Village, Melaya District, Jembrana Regency. The collaboration with the West Bali National Park Office has been carried out starting in January 2022, starting with a meeting with the Melaya Village Headquarters (Mr. I Nyoman Warsana) related to Optimizing Local Wisdom in Supporting Villages and Synchronization The rights and obligations of the parties between the people of Dusun Klatakan and the Melaya Village as one of the Buffer Villages at the West Bali National Park Hall.

In addition, this Community Service can be carried out because it begins with the implementation of our research at the West Bali National Park Center through the Independent Campus Study Program so that close relationships with the West Bali National Park Center and also

the Supporting Villages have been established since we carried out the research program, and we also know things that are still needed for synchronization, as well as maximizing and optimizing community groups, as well as buffer villages in the West Bali National Park Center so that the Conservation of the West Bali National Park Center can be carried out and maintained properly, as well as the buffer village community enjoying the results of the conservation of the West Bali National Park Center for the welfare of the residents of the surrounding Buffer Village. After intensive communication with the Melaya Village Perbekel and staff and also the Klatakan Hamlet community, as well as the West Bali National Park Office, it was agreed that our Community Service Team, together with the Melaya Village Perbekel, and from the West Bali National Park Office, did the service to the community according to the service title, namely "PKM Community Empowerment of the Supporting Village Against the West Bali National Park Office, Jembrana Regency" carried out in Klatakan Hamlet, Melaya Village, Melaya District, Jembrana Regency on the day/date: Thursday, 26 May 2022. We are the Community Service Team on Thursday, May 26, 2022 Morning. pk. 08.00 already departed from Denpasar to Dusun Klatakan with two (2) trash bins to be donated to Dusun Klatakan, Melaya Village, as well as Consumption and Snacks and drinks for community service participants in Dusun Klatakan.

The team from the West Bali National Center, namely Mr. I Putu Gede Arya Kusdyana, S.Hut., M.Sc and Nana Rukmana and Desa Melaya, Mr. Perbekel for some reason could not attend but was represented by the Village Secretary/Sekdes Melaya (Mr. Nyoman Swasana), Chairman of the Klatakan Hamlet Community Group (Mr. Kadek Budiarsa) along with 25 residents of the Klatakan Hamlet community were present at the implementation of community service in Melaya Village in collaboration with the West Bali National Park Office. The Community Service Team arrived at the service location, Klatakan Hamlet, Melaya Village, Kec. Melaya, Jembrana Regency at Pk. 12.00 Noon. We, the FH Unwar Service Team, who came from Denpasar when we arrived at the Service location in Klatakan Hamlet, had already received Dear. Mr. Village Secretary/Secretary of Melaya Village (Mr. Nyoman swasana), Mr. Head of Dusun Klatakan (Mr. Abdul Syakur), the residents of Klatakan Hamlet and the Head of a community group called the "Learning House Group" (Mr. Kadek Budiarsa), as well as the team from the National Park Authority. West Bali, namely Mr. I Putu Gede Arya Kusdyana, S.Hut., M.Sc and Mr. Nana Rukmana. So that after offering offerings and Pejati at the padmasana in the Balai banjar Dusun Klatakan as well as praying, the community service activities are carried out properly, smoothly and successfully.

The results of the Implementation of Community Service in 2022, the implementing Teams of Community Service in Dusun Klatakan. In the implementation of community service in Klatakan Hamlet, after the Head of the Community Service Team (Dr Luh Putu Sudini, S.H., M.Hum) delivered an introduction containing the goals and objectives of this community service activity, the Faculty of Law, Warmadewa University, to all participants who attended the activity. Service, then there are inputs or responses as well as question and answer activities between the residents of Dusun Klatakan, village officials, such as Mr. SekDes Melaya, Head of Klatakan Hamlet, as well as from the West Bali National Park Team, according to the Community Service Theme which was carried out at that time.

The results obtained in community service activities in Klatakan Hamlet include: Mr. I Gede Suwartono (a resident of Klatakan hamlet), related to the cooperation contract with the West Bali National Park Authority, which is the authority of the Melaya Village, but in Klatakan Hamlet has a community group and is also active in "waste handling" activities, which are in the implementation of waste handling activities. This resident of the Klatakan Hamlet community group was accompanied by the Melaya Village, and also from the West Bali National Park Office. The rights and obligations of the Klatakan hamlet community are only as a counterpart to the Village, in this case the Melaya Village. Waste management in Klatakan Hamlet until now has not run optimally because the budget given is only 20 million per year, there are two (2) Waste Management Subsidies. Handling waste per year for one manager costs 12 million rupiah.

Thus, waste management activities in Klatakan Hamlet, Melaya Village still need funding from other parties. According to Mr. I Gede Suwartono (a resident of Dusun Klatakan) he hopes that waste management in Dusun Klatakan can be carried out properly. The people of Dusun Klatakan want to clean up inorganic waste and produce non-plastic waste. In other words, it is separated between plastic waste and non-plastic waste, so that non-plastic waste can be produced into goods that are

useful for human life, such as the possibility that it can be used as souvenirs for tourists who come to Dusun Klatakan. Thus the activities of the residents of the Klatakan Hamlet can provide goodness or benefit to the Dusun, as well as the Melaya Village. In addition, Mr. I Gede Suwartono, hopes that in order to prepare the younger generation of Klatakan village to be able to speak English, free education or training is needed. Requested assistance from Warmadewa University Denpasar. Furthermore, Mr. Kadek Budiarsa (Chairman of the Klatakan Hamlet Community Group), stated that the Klatakan Hamlet, Melaya Village began collaborating with the West Bali National Park Office in 2019, so that cooperation is still young. In the implementation of activities in the Klatakan Hamlet, it appears that the people of Klatakan Hamlet do not have intense communication with the Melaya Village or the West Bali National Park Office.

The people of Dusun Klatakan, Desa Melaya really need an intense collaboration both with Desa Melaya, and the West Bali National Park Center so that the residents of Dusun Klatakan will gain knowledge such as how to organize in groups, access to which can be informed to the community so that the residents of Dusun Klatakan are able to help the West Bali National Park Office maintain, preserve the Forest Conservation in the West Bali National Park Hall. In addition, there is also a need for intensive training from the West Bali National Park Center for the residents of the Klatakan Hamlet, Melaya Village as one of the Supporting Villages for the West Bali National Park. In addition, the entire community must know the negative and positive impacts as well as the rights and obligations of citizens in the West Bali National Park. For example: Do not enter the forest, also Animals in the West Bali National Park entering the Klatakan Hamlet or Melaya Village can these animals be categorized as belonging to the Klatakan Hamlet or the Melaya Village? In this regard, there has been no firm explanation from the West Bali National Park to the residents of the Klatakan Hamlet, Melaya Village. Furthermore, the question and answer activity in this community service activity was given an explanation by the West Bali National Park Team team, namely Mr. Nana Rukmana (Assistant from TNBB), stating that the Cooperation between Melaya Villages was through Mr. Perbekel Melaya Village (Mr. I Nyoman Warsana) and the Head of the West Bali National Park Center (Mr. Drs. Agus Krisna Kepakisan, M.Si) has occurred since 2019. Rights and Obligations can provide access to the people of Dusun Klatakan, Melaya Village to maintain and preserve Forest Conservation in the West Bali National Park.

In addition, the West Bali National Park Center is always ready to assist every community activity with the Klatakan Village Group of Melaya Village. In November 2020, the Klatakan Hamlet, Melaya Village had just entered the West Bali National Park, and at that time there were already inaugurated groups, but there were no activities or activities were still empty. In 2009 the Bali Starling in another hamlet in the West Bali National Park was not maintained properly so the existence of the Bali Starling ended. According to Mr. Nana Rukmana (assistant from TNBB) that the potential of the West Bali National Park in Klatakan Hamlet, Melaya Village can run well, this can be seen from the progress of the Klatakan Hamlet, Melaya Village and also the synergy with the West Bali National Park. For example: in Klatakan Hamlet, Melaya Village, there is already a Learning House Group, while the TNBB cares for the residents of Klatakan Hamlet, namely providing lighting electricity through PLN. Thus there is a synergy between TNBB, the people of Dusun Klatakan and Desa Melaya. In addition, Mr. Nana Rukmana as a companion from TNBB, hopes that Unwar can provide assistance in the form of:

- 1) Legal role models for Regency or Provincial Regulations, especially Hamlet Tourism. Garbage field regulations.
- 2) Utilization or special techniques regarding waste can be used as souvenirs. And
- 3) The Governor or Regent in the form of a policy for the management of Dusun Klatakan there is a KPH.

Mr. Nana Rukmana, also stated that Dusun Klatakan has a lot of tourism potential, such as: Shrimp or Lobster; Waste is managed into souvenirs; NGOs to assist activities; Tourism education related to animals, such as Bali starlings, owls, etc. needs community management. Implementation of community service in the Klatakan Hamlet, Melaya Village, Melaya District, Jembrana Regency. After the Q&A and discussion activities, the Community Service Team handed over a donation in the form of two (2) trash bins for the Klatakan Village, Melaya hamlet. In addition, the Community Service Team also distributed snacks, boxed rice, and drinking water to all participants in community service activities. Finally, the service activity was closed by the Team Leader at Pk. 14.00 Wita, with

thanks to Mr. Perbekel Desa Melaya or his representative, namely Mr. SekDes Melaya, also the Head of Dusun Klatakan, and all members of the community of Dusun Klatakan, Desa Melaya, as well as the Assistance Team from the West Bali National Park Office, totaling two (2) people, I hope that the Klatakan Hamlet, Melaya Village as a Supporting Village for the TNBB Hall can continue to work together well and intensely for the conservation of TNBB to be good, sustainable and successful.

#### 3.2 Optimizing Local Wisdom of the Village Supporting West Bali National Park

Melaya Village, Melaya District, Jembrana Regency is one of the Buffer Villages for the West Bali National Park. On this occasion, the service was focused on Klatakan Hamlet, Melaya Village, Melaya District, Jembrana Regency. Based on the results of the implementation of community service by the Service Team, which was held on Saturday, June 26, 2022 in Dusun Klatakan, it can be seen that the results of interviews with residents of Dusun Klatakan namely Mr. I Gede Suwartono, that there is a lack of community optimization of local wisdom of the village community Support for the West Bali National Park Hall. For example, the handling of waste in Klatakan Hamlet is still not running optimally or effectively because the budget given is only 20 million per year, there are two (2) Waste Management Subsidies. Handling waste per year for one manager costs 12 million rupiah. Thus, waste management activities in Klatakan Hamlet, Melaya Village still need funding from other parties. According to Mr. I Gede Suwartono (a resident of Dusun Klatakan) he hopes that waste management in Dusun Klatakan can be carried out properly.

The people of Dusun Klatakan want to clean up inorganic waste and produce non-plastic waste. In other words, it is separated between plastic waste and non-plastic waste, so that non-plastic waste can be produced into goods that are useful for human life, such as the possibility that it can be used as souvenirs for tourists who come to Dusun Klatakan. # 3.3 Synchronization of the Rights and Obligations of the Parties between the Klatakan Hamlet Community with Malay Village

Melaya Village as one of the Buffer Villages at the West Bali National Park Center, on this occasion the focus was on Klatakan Hamlet, Melaya Village, Melaya District, Jembrana Regency. According to the results of the implementation of community service in Klatakan Hamlet, Melaya Village, Kec. Malay, Kab. Jembrana on Day/date: Saturday, June 26, 2022 stated that the rights and obligations of the people of Dusun Klatakan are only as a counterpart to Melaya Village, which is one of the Supporting Villages of the West Bali National Park. Furthermore, from the West Bali National Park, Mr. Nana Rukmana (as an assistant) stated that the collaboration between the Melaya Village through Mr. Perbekel Desa Melaya (Mr. I Nyoman Warsana) and the Head of the West Bali National Park Center (Mr. Drs. Agus Krisna Kepakisan, M. .Si) occurred since 2019. Rights and Obligations can provide access to the people of Dusun Klatakan, Desa Melaya, to maintain and preserve Forest Conservation in the West Bali National Park.

In addition, the West Bali National Park Center is always ready to assist every community activity with the Klatakan Village Group of Melaya Village. In November 2020, the Klatakan Hamlet, Melaya Village had just entered the West Bali National Park, and at that time there were already inaugurated groups, but there were no activities or activities were still empty. In 2009 the Bali Starling in another hamlet in the West Bali National Park was not maintained properly so the existence of the Bali Starling ended. According to Mr. Nana Rukmana (assistant from TNBB) that the potential of the West Bali National Park in Klatakan Hamlet, Melaya Village can run well, this can be seen from the progress of the Klatakan Hamlet, Melaya Village and also the synergy with the West Bali National Park. - 2) Utilization or special techniques regarding waste can be used as souvenirs. And
- 3) the Governor or Regent in the form of a policy on the management of Dusun Klatakan there is a Forest Management Unit (KPH).

Mr. Nana Rukmana, also stated that Dusun Klatakan has a lot of tourism potential, such as: Shrimp or Lobster; Waste is managed into souvenirs; Foreign organizations (NGOs) to assist activities; Tourism education related to animals, such as Bali starlings, owls, etc. needs community management. Thus, it appears that there is a verbal agreement between the Supporting Village (in this case the Melaya Village, Klatakan Village) and the West Bali National Park Office (considering that the existing cooperation between Klatakan Hamlet is only as a comparison for the Melaya Village), but the agreement has not yet been stated. in writing. In other words, the existing cooperation between the Klatakan Hamlet and the Melaya Village as one of the Buffer Villages at the West Bali National Park Center is not synchronized. We, as the Community Service Team, provide input so that collaboration between Dusun Klatakan, Melaya Village as one of the Supporting Villages for the West Bali National Park must be written in writing, to avoid any unexpected risks.

#### III. CONCLUSIONS

Based on the description in the discussion chapter, the following conclusions can be drawn: Melaya Village as one of the Buffer Villages at the West Bali National Park Office, there seems to be a lack of community optimization of the local wisdom of the Supporting Village community towards the West Bali National Park Hall. The rights and obligations of the parties between the people of Dusun Klatakan and the Melaya Village as one of the Buffer Villages at the West Bali National Park Hall, in the cooperation contract there is no synchronization.

At this opportunity, the following suggestions can be made: There needs to be effective guidance and attention by the West Bali National Park Office towards Melaya Village as one of the Buffer Villages for the West Bali National Park Office, as well as to the residents of the Klatakan Hamlet through the Klatakan Hamlet community group to be able to realize the West Bali National Park Hall good and sustainable. There needs to be further service activities in Klatakan Hamlet, Melaya Village, Melaya District, Jembrana Regency to help the community and Melaya Village be more active and effective as one of the Buffer Villages for the West Bali National Park Center so that the Protected Forest of the West Bali National Park is maintained, and sustainable.
